KEY POINTS

-ve North East Lincolnshire had the lowest percentage of NHS organisations with a board approved sustainable development plan out of all the local authorities in the Yorkshire and the Humber. The North East Lincolnshire percentage (16.7%) was lower than both the England (41.6%) and regional (48.5%) averages. The North East Lincolnshire percentage (16.7%) equates to only one out of six organisations.

DESCRIPTION

Climate change is a major public health issue. Sustainable development provides a framework for balancing economic, social and environmental considerations, including climate change – this supports public health through strengthening community resilience and reducing health inequalities in addition to adapting for the years ahead. Achievement of a sustainable, low carbon, public sector will not be possible without monitoring and measuring progress. Sustainable Development Management Plans are the first step in the process for NHS organisations becoming more aware of sustainability issues and the only current mechanism for monitoring progress. They set out a range of actions which will contribute towards increased sustainability and reduced CO2 emissions. 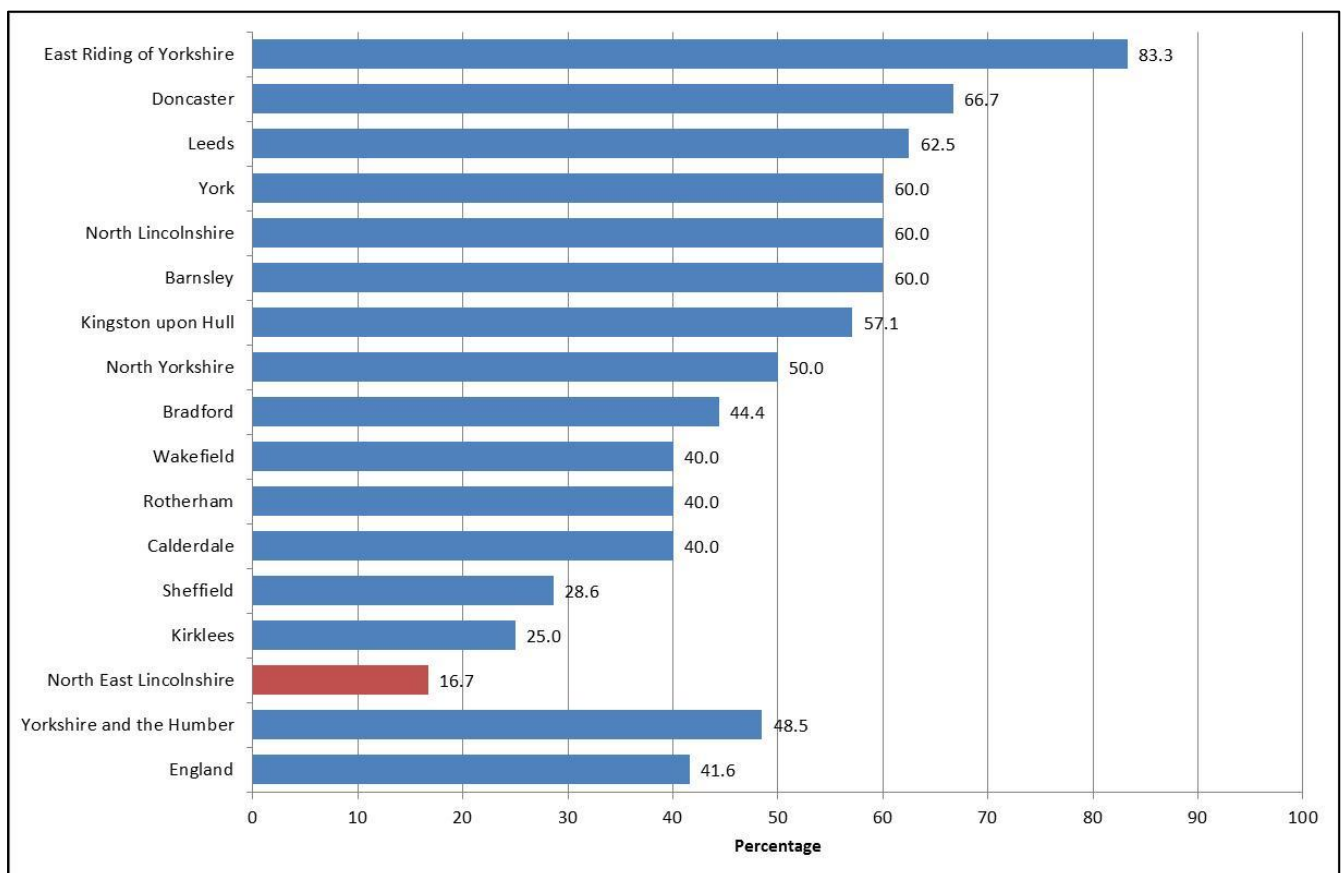

The indicator measures the percentage of NHS organisations assigned to the local authority where the board approved a sustainable development management plan in the preceding 12 months.

NATIONAL, REGIONAL OR PEER GROUP

Figures presented in Figure 1 show that for 2013/14, North East Lincolnshire had the lowest percentage of NHS organisations with a board approved sustainable development plan out of all the local authorities in the Yorkshire and the Humber. The North East Lincolnshire rate percentage (16.7%) was lower than both the England (41.6%) and regional (48.5%) averages. The North East Lincolnshire percentage (16.7%) equates to one only out of six organisations.

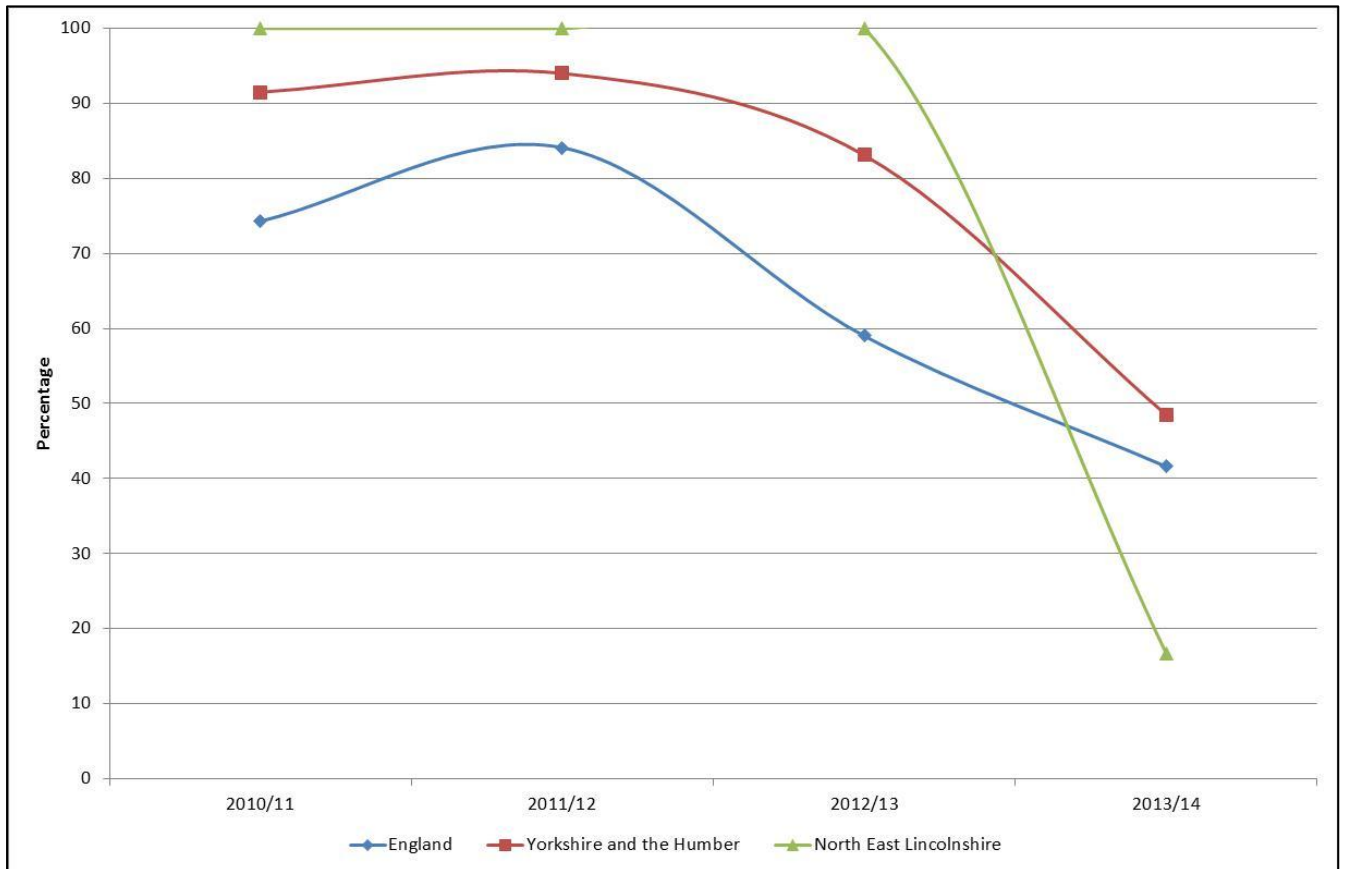

TRENDS, TARGETS & PROJECTIONS

Figures presented in Figure 2 show that the percentage of NHS organisations with a board approved sustainable development plan, has fallen considerable throughout England and the Yorkshire and the Humber, and has fallen dramatically in North East Lincolnshire.

These data were collected in March 2014. Recent major NHS reforms meant that commissioning organisations (notably NHS England and CCGs) were new organisations. This has resulted in a low proportion of some organisations types confirming that they have a sustainable development management plan in place. This should be taken into account when comparing these data with previous years. (Improving outcomes and supporting transparency - Part 2, Department of Health, 2012).
